# CHILD SAFETY

A family day care educator must ensure that they are providing an environment where each child's safety is protected.<sup>1</sup>

The National Regulations require your scheme to have specific policies and procedures in place<sup>2</sup> with many contributing to the provision of a safe environment for children.

# **Key Points**

Each child's right to feel safe and be protected within their education and care environment is crucial. Providing a safe environment for children within your service involves the consideration of a number of aspects including:

- Managing the supervision of children within your home; during play sessions; and during all excursions and outings;
- Understanding what your responsibilities are with responding to children at risk of harm;
- Assisting children to understand and respect their environment including their participation in the development of safety rules and guidelines where appropriate;
- Your management of risks associated with the use of your home environment; and with the use of the broader community;
- Managing incidents and emergencies that occur in your service;
- Monitoring who has access to your service and ensuring that children are only released to authorised nominees;

- Understanding and following your service policies and procedures; and
- The possibility that safety and the management of risks may require varied strategies within different locations.

• Are you familiar with your service's policies and procedures?

Do you have systems in place with regard to your management of:

- Supervising children within your home environment?
- Supervising children during excursions and/or outings?
- Supervising children during service or community play sessions?
- Visitors to your home?
- Potential risks from dangerous products, plants, animals and objects?
- The transportation of children in line with current standards and laws?
- Emergency situations, action plans and rehearsals?
- The inclusion of children in safety discussions, risk identification and management?
- Maintaining your knowledge of current child protection legislation?
- The arrival and departure of children?
